- 4 Applications without photograph, signature, necessary marks cards and certificates in support of their application shall be summarily rejected.
- 5 The qualifications prescribed should have been obtained through recognized Universities/ Institutions.
- The prescribed Essential Qualifications are a bare minimum and mere possession of it, will not entitle the candidates to be considered for the post.
